# Believers' LoveWorld, UK Zone1 - Data Privacy Policy

### Introduction

Your personal data is data which by itself or with other data available to us can be used to identify you. As the data controller, Believers' LoveWorld (BLW) UK Zone1 Ltd, a member of the Believers' LoveWorld (BLW) Inc, are committed to protecting your personal data. ## The types of personal data we collect about you

Whether you are a member or a prospective member, we will use your personal data for the reasons set our in this policy; and for our members, we will use it to manage your membership with us. Most of these data are collected directly from you. Where we collect data about you indirectly, the sources are mentioned in this statement. The personal data we use may include;

- Full name and contact details including home/office address; email address, mobile and home numbers.
- Date of birth / age group
- Records of departments, cell, partnership arms and meetings you belong to or attend
- Family, lifestyle or social circumstances where relevant
- Education and employment details

This information may also be obtained from other organisations or people, such as other BLW arms/churches or your family members/contacts.

## The legal basis and purposes for using your personal data;

We will process your personal data:

- 1. As necessary for our own legitimate interests or those of other persons and organisations, e.g.:
  - a. To provide and manage our relationship with you
  - b. To communicate with you (such as our church meetings and events)
  - c. To protect BLW's and BLW UK Zone 1's interest
  - d. To share your information with any other organisation in line with our data privacy policy; eg another BLW church or arm.
- 2. As necessary to comply with a legal obligation, e.g.:
  - a. When you exercise your rights under data protection law and make requests:
  - b. For compliance with legal and regulatory requirements and related disclosures
- 3. Based on your consent, e.g.:
  - a. When we require your consent to process special categories of personal data about you (religious beliefs, data concerning your health, your racial or ethnic origin)

### Sharing of your personal data

Subject to applicable data protection laws we may share your personal data with:

- BLW churches and BLW associated organisations
- Organisations which help us service your membership with us
- Companies and other persons providing services to us
- Our legal and other professional advisors, including our auditors;
- Courts, to comply with legal requirements, and for the administration of justice
- In an emergency or to otherwise protect your vital interests;

- To protect the security and integrity of the BLW
- Anyone else where we have your consent or as required by law.

The people and organisations listed above will also have to keep it secure and confidential.

#### International transfers

Your personal data may be transferred outside the UK and the European Economic Area. Necessary steps will be taken to ensure appropriate safeguards of your personal data when they are transferred internationally.

# Information about other people

If you give us information about other people (such as members of your household or contacts), which we will use to provide services set out in this policy, you are confirming that you have provided those people with a copy of this policy.

# Your contact preferences

We will use your phone numbers, email address, home address and social media to contact you according to your preferences. You can change your preferences by contacting us. Social media preferences can be updated on the applicable social media platform.

## How long we will keep your information

We will keep your information for as long as is needed for the purposes set out above or as required by any applicable law.

If you formally withdraw your membership with us, we'll still keep your information for as long as we're allowed to, for BLW's legitimate purposes.

## Your rights

Your rights are as follows;

- The rights to be informed about our processing of your personal data
- The right to have your personal data corrected it it's inaccurate and to have incomplete personal data completed
- The right to object to processing of your personal data
- The right to restrict processing of your personal data
- The right to have your personal data erased
- The right to requests access to your personal data and details around how we process it
- The right to move, copy or transfer your personal data; and
- Rights in relation to automated decision making, including profiling

You also have the right to complain to the Information Commissioner's Office.
